

Background

- Economic Development Agency (EDA) Good Jobs NOFO
 - \$500 million for good jobs and EDA plans on funding 25-50 awards (\$10-20 million per project)
 - Grant or cooperative agreement.
 - Submission deadline January 22, 2022
 - Projects will be awarded through Sept. 30, 2022 and projects must be completed by Sept 30, 2027.





Background

- Economic Development Agency (EDA) Good Jobs NOFO
 - All projects considered for EDA funding under this ARPA Good Jobs Challenge NOFO must be consistent with EDA's Recovery and Resilience Investment Priority.
 - Each project funded under this NOFO must be consistent with the region's current Comprehensive Economic Development Strategy (CEDS).






Regional Workforce Training System

Regional training system for four seafood sectors:

- 1. Commercial
- 2. For-hire
- 3. Aquaculture
- 4. Processing








Sectoral Partnership

Example backbone organization, strategic and Industry partners in a hypothetical sectoral partnership.








Regional Workforce Training System Components

- Phase 1: System Development
 - Funding to help a System
 Lead Entity establish and
 develop a regional
 workforce training system
 comprised of multiple sector
 partnerships.







Regional Workforce Training System Components

- Phase 2: Program Design
 - Funding for sectoral partnership(s) to:
 - identify the skills needed by industry and workers,
 - develop the skills training curriculum and materials, and
 - secure technical expertise needed to train workers with the skills needed by businesses, including providing professional development and capacity-building to trainers and educators.







Regional Workforce Training System Components

- Phase 3: Program Implementation
 - Funding to deliver workforce training and wrap-around services that place workers into quality jobs through a new or expanded sectoral partnership(s).

EDA plans to make an award to a System Lead Entity or Backbone Organization to fund the System Development, Program Design, and/or Program Implementation requirements of the system.





System Lead Entity

System Lead Entity

 Serves as an intermediary that organizes and works with employers, training participants, employees, government agencies, and other organizations to solve problems within sectors and help grow sectors by developing trust and a base of knowledge about the organizations and businesses, as well as available public and private resources.





System Lead Entity

- In a mature regional workforce training system
 - System Lead Entity supports multiple sectoral partnerships, and
 - each of those sectoral partnerships is convened by its respective Backbone Organization.
 - The System Lead Entity supports and facilitates connections between the Backbone Organizations.

- The Gulf States Marine Fisheries
 Commission is asked to:
 - Serve as THE System Lead Entity for an EDA proposal to develop and implement a Regional Seafood Workforce Training System
