MEETING NOTICE

GULF STATES MARINE FISHERIES COMMISSION 68th Annual Spring Meeting

March 13-15, 2018 – Panama City Beach, Florida

The Gulf States Marine Fisheries Commission's 68th Annual Spring Meeting will be held March 13-15, 2018 at the Sheraton Bay Point Resort in Panama City, Florida. This notice contains meeting details, including the preliminary meeting schedule. All of the business meetings scheduled during this week are open to the public, free of charge. Please note the preliminary schedule is subject to change. Senator R.L. "Bret" Allain, Louisiana State Senate, is the presiding Chairman of the Commission.

ACCOMODATIONS: Florida is our host state and arrangements have been made to convene at the Sheraton Bay Point Resort (4114 Jan Cooley Drive, Panama City Beach, Florida 32408). Surrounded by the emerald green waters of St. Andrews Bay and the Gulf of Mexico, Sheraton Bay Point Resort sits nestled within a 1,100 acre wildlife sanctuary. Boasting a \$30-million renovation and AAA Four Diamond rating, the hotel is a dazzling, award-winning beachfront destination. Amenities include several heated pools, a full-service spa, a 24-hour fitness center and 36 holes of championship golf, including the only Nicklaus Design course in Northwest Florida.

A block of rooms is being held at the negotiated room rate of **\$116.00** plus state/local tax (currently 12%). Rates will be available 3 days prior and 3 days after the Event Dates (subject to availability). The \$25.00 Resort Fee is waived for our group and includes guestroom internet, self-parking, access to 24 hour fitness center, private bay beach and resort pools. ***GENERAL SESSION: OFF-BOTTOM OYSTER AQUACULTURE IN THE GULF OF MEXICO** – In 2016, the Commission began a cooperative effort with NOAA's Office of Aquaculture to develop and manage a small grants program to address the technical and regulatory opportunities and challenges of oyster farming in the Gulf region. A total of six projects were funded across the Gulf at a total of \$375,000. Now that those projects have been completed, each of the Principal Investigators will present the extent of their work at the General Session scheduled for Wednesday, March 14. NOAA and the Commission have launched a second year of projects which will begin next month and run through March 2019.
